Policy Governance

The School Board sets [Policy Governance policies](#) [3], which focus on results or “ends” – what Bellingham School District graduates should know, understand and be able to do. By governing at this level, the Board avoids micro-managing the work of the district. Instead, the School Board holds the superintendent accountable for implementing the Board’s vision by monitoring results through the use of data, reports and focused discussions. The work of the School Board includes listening to the public and gathering their feedback about goals, standards and progress through community outreach linkages.
