A Message from the Attendance Areas PreK-12 Standing Committee

Dear Cordata Families,

You are receiving this letter because you live in an area that is being considered for a school attendance area adjustment from Cordata Elementary School to either Alderwood, Parkview or Northern Heights starting next school year. **Please see the maps linked below to determine your new proposed elementary school.**

Earlier this school year, Bellingham Public Schools shared information about the growth happening in north Bellingham, and its current and future impact on school enrollment. Families also received information to apply for consideration to serve on the Attendance Areas PreK-12 Standing Committee.

Our group of students, parents and staff has been meeting weekly this winter. One of the issues we've been working on is how to create more enrollment space at Cordata because the school is now full. In the future, areas around Cordata are predicted to continue to grow. We have been thoughtfully considering how to make this adjustment. At this time, we want to share this draft attendance area proposal that represents our group's best thinking.

In the current proposal:

- Cordata students who live in the area outlined in the enclosed map would attend **Alderwood** Elementary starting in August. School bus transportation to and from the neighborhood to Alderwood will be provided.
- Cordata students who live in the area outlined in the enclosed map would attend **Parkview** Elementary starting in August. School bus transportation to and from the neighborhood to Parkview will be provided.
- Cordata students who live in the area outlined in the enclosed map would attend **Northern Heights** Elementary starting in August. School bus transportation to and from the neighborhood to Northern Heights will be provided.
- Students who have moved into the new **Villa Santa Fe** housing complex off Bakerview Road near Cordata are currently under an involuntary transfer to attend Alderwood until more space is available at Cordata. In this proposal, Villa Santa Fe students attend Cordata starting in August.

In this proposal, transfer requests are likely to be approved *only* in unique circumstances. For those requesting a transfer to remain at Cordata, school bus transportation would not be provided. Requests should be submitted using this special form by March 15.

Also for those families who want to hear more about our work in person, ask questions and give verbal feedback, our advisory group will hold a **parent input session from 6 to 7:30 p.m. Thursday, March 9 in the Cordata Elementary School cafeteria.** Please save the date!

Our committee used the following [policy 3130](#) criteria to develop our attendance area draft for your input:

- Minimize disruption of student's established learning programs.
- Keep siblings in the same elementary, middle or high school, whenever possible.
- Provide overall balance of student enrollment related to facility size, taking into account future growth patterns.
- Provide a reasonably balanced socio-economic relationship in all schools.
- Provide the most efficient and feasible means for student transportation to and from school, including whether safe routes to school might exist, minimizing travel time and transportation costs.
- Keep neighborhoods together, whenever possible.
- Maintain feeder school patterns so that elementary/middle/high school attendance areas coincide and students stay with the same cohort as they progress through school levels, whenever possible.
- Follow natural boundaries and utilize existing physical boundaries such as major roadways to delineate boundaries, whenever possible.

In looking at which neighborhoods to select for this adjustment, our advisory group also considered proximity to other elementary schools and schools with available space. Students living in these areas could make this adjustment together. North Bellingham is growing and projections show more adjustments will likely be needed in future years to create more space at Cordata, Shuksan and Squalicum. Next Steps: Our group will review the feedback from the survey, share more of our rationale at the input meeting, and take input into consideration at the parent input session from 6 to 7:30 p.m. **Thursday, March 9 in the Cordata Elementary School cafeteria.** Our advisory group will meet to consider the input on March 16 before submitting a recommendation to the superintendent. The superintendent will then consider our recommendation, make a decision and communicate with families. **We anticipate a decision by the end of March to allow students to attend welcome events and orientations at their new schools this spring.**
